WE HEREBY AFFIRM:

- A. That the entire net proceeds of all raffles will be exclusively devoted to the lawful purpose of the organization.
- B. That the retail value of all prizes or merchandise in a single raffle will not exceed \$50,000 and the maximum retail value of each prize will not exceed \$25,000 in a single raffle.
- C. That the maximum price for each chance will not exceed \$500.00.
- D. The chances will be sold within a period not to exceed 180 days.
- E. That only bona fide members of the organization shall participate in the management or operation of raffles.
- F. That no person shall receive remuneration or profit for participating in the management or operation of a raffle.
- G. That no person under the age of 18 years will participate in conducting the raffle or will be present when winners are determined unless accompanied by a parent or guardian.
- H. That records of gross receipts, expenses and net proceeds will be segregated from other revenue and that the person who keeps such records shall not be the same person who accounts for other revenue of the organization.
- I. That gross receipts, expenses and net proceeds will be reported to the membership of the organization and to the Urbana City Clerk at conclusion of raffles.
- J. That required records will be preserved for three (3) years after raffles and available for public inspection at reasonable times and places.
- K. All bills, billboards, placards or other advertisements will contain the name of the organization conducting raffles.
- L. All tickets or chances will contain the number of the license issued by the City.
