The cost of renting a meter bag is \$17.00 per meter per day. If two meter heads are on one post, both meters must be bagged and paid for. Requests received with less than 24 hours' notice will cost \$22.00 per meter for the first day and \$17.00 per meter per day for each additional day. Meter(s) bagged specifically for a Sunday will be charged for a Saturday. If changes need to be made to the agreement, it is the Renter's responsibility to provide the City of Urbana with 24-hour notice by phoning the Urbana Parking Meter Maintenance Division at 217-384-2314 or the Urbana Finance Department at 217-384-2345. If a full 24-hour notice is not given, the Renter may be responsible for an additional day's charge. Further, if construction is involved with the meter reservation request that will require temporary removal of the meter post(s), the post(s) can be removed **after** Urbana Public Works Department has removed the meter head(s). The reservation fee will be charged until the meter post(s) is/are replaced to the prescribed standards of the Urbana Public Works Department. This agreement shall be in effect until either party notifies the other in writing that the agreement is changed or cancelled. The City reserves the right to terminate the agreement at any time, with 30 days notice.

I request the meter(s) at the listed locations above be "bagged" as reserved for my use during the term of this agreement. I agree to pay for the use of \_\_\_\_\_ space(s) at the rate of \$17.00 per day per space, exclusive of Sundays, for each day during the period of this agreement.
