3. Approval of Minutes from Previous Meetings

- c. Audit report was presented. Elizabeth Hannan moved to accept. Josh Ingold seconded. Roll call: Elizabeth Hannan yes, Josh Ingold yes, Robert Kouzmanoff yes. Motion passed.
- d. Renewal of Fiduciary Liability Insurance policy effective 2/1/2024-2/1/2025 for \$3925. Move to renew on those terms by Elizabeth Hannan, second by Josh Ingold. Roll call: Elizabeth Hannan yes, Josh Ingold yes, Robert Kouzmanoff yes. Motion passed.
- e. Ron Eldridge reviewed the financial report. Total return for the quarter at the state investment fund was 8.7% which is nearly identical to the benchmark. He also commented on the

Wallace turned 55 11/23 and received a 3% increase in December. J. Kingston retired 11/29/23 with 25 years service \$6728.11 per month. M. Stewart awarded line of duty disability pension effective 6/23/23 in the amount of 4955.71 per month. Future changes: M. Humer is eligible pension. F. Westhoff turns 55 in 3/24 4% raise in 4/24. J. Kingston will receive a 3% raise in 12/24.
