I. CALL TO ORDER AND ROLL CALL

There being a quorum, Mayor Marlin called the meeting of the Urbana City Council to order at 7:02 p.m.

II. PUBLIC INPUT

There was none.

III. **ORDINANCE NO. 2017-05-022:** An Ordinance Amending Urbana City Code Chapter 14, Section 14-7, Regarding the Schedule of Fees (July 1, 2017, Through June 30, 2018) – [COW 05-08-17]

From 7:03-7:08pm. Alderman Miller recused himself from participating in the voting of this item due to conflict of interest as a manager for a business who has a liquor license in the City of Urbana. After staff presentation, Alderman Miller said he would like to separate this ordinance into two different items as it was done during Alderman Madigan's term as a business owner with a liquor license.

Administrative Services Supervisor Elizabeth Beaty presented updates made to the ordinance as requested by committee members from its May 8, 2017 Committee of the Whole meeting. At that meeting, staff was directed to remove Vehicle for Hire companies. Staff also decided not to increase parking meter rates after it was discovered that the City of Champaign and University of Illinois were not going to increase their parking meter rates.

After the presentation Alderman Jakobsson made a motion to separate liquor related items from this ordinance. Alderwoman Wu seconded. Motion carried by voice vote.

Alderman Brown made a motion to approve the ordinance, excluding liquor related items. Alderman Miller seconded. Motion carried by roll call vote. Votes were as follows:

Ammons – Aye	Jakobsson - Aye
Brown – Aye	Miller - Aye
Hazen – Aye	Wu - Aye

Disposition: Ordinance excluding liquor fees was approved by roll call vote (6-Aye: 0-Nay).

Alderman Miller recused himself from voting on this item, due to conflict of interest, as he is a manager for a business that holds a liquor license in the City of Urbana.

Alderman Brown made a motion to approve the fee schedule for liquor licenses and related items. Alderman Ammons seconded. Motion carried by roll call vote. Votes were as follows:

Brown – Aye	Miller - Recused
Hazen – Aye	Wu - Aye

Disposition: Ordinance for the liquor licenses fees was approved by roll call vote (5-Aye: 0-Nay).

IV. ADJOURNMENT

There being no further business to come before the City Council, Mayor Marlin declared the meeting adjourned at 7:09 p.m.
