He then thanked R. Eldridge for accepting the appointment; R. Eldridge has always contributed greatly to the Fund.

Old Business:

Minutes (4/24/20): Motion by E. Hannan to approve the Minutes of 4/24/20; second by S. Royal.

<u>Police Pension Administrative Rules</u>: D. Smysor recommended the Board table this item until the Board knows more about the consolidation.

<u>IDOI Audit:</u> Discussion about the Fund's communication w/ the Department of Insurance; nothing further.

New Business:

<u>Public Participation:</u> D. Smysor stated he received no communication from the public.

Refund of Contributions:

- <u>Benjamin Crane</u>: B. Crane resigned from the City, taking a position of Police Officer at UIPD. His refund of contributions totaled \$19,956.61; this check was sent on March 6, 2020.
- <u>Justin Walker</u>: J. Walker's refund of contributions totaled \$5,033.08; this check was sent on August 13, 2019.

Motion by S. Royal, second by E. Hannan to approve the disbursement of funds to Crane and Walker.

<u>Christopher Whelchel Disability Hearing:</u> His Hearing is still pending; records are being gathered.

<u>Board Appointment: Ron Eldridge (expires 06/30/23):</u> Mayor Marlin appointed R. Eldridge to the Board; the Board welcomes Ron's return.

<u>Tax Levy Actuarial Valuation-Lauterbach & Amen:</u> E. Hannan discussed the engagement letter for the City actuary. Motion by E. Hannan for the Board to approve the engagement of Lauterbach & Amen to do the Fund's actuarial review for 6/30/20-6/30/22; second by S. Royal, Motion passed.

Financial Report:

- Quarterly Report (April-June 2020); R. Eldridge reported there was no unusual activity, no changes in benefits.
- Annual Financial Report: R. Eldridge stated this year showed an increase in net assets, but, in comparing it with past years, this was not a great year for the Fund (downturn in stock market and equities). He further reviewed the Fund's activity and performance, pensioner changes, deferred pensioners, etc.
 - Buyback of Time-FMLA: J. Dobrovolny stated the employee is entitled to buy back service; J. Dobrovolny will report his findings to the Board.

Motion by E. Hannan to accept the annual and quarterly reports, as presented, second by S. Royal, motion passed.
