I. ROLL CALL

Chair Marlin called the Public Hearing of the Cunningham Township Board to order at 7:01 p.m. Chair Marlin opened the hearing and stated the purpose of the hearing, which was to receive public input on a proposed property tax increase for the Town of Cunningham for 2019.

She read the hearing notice, as follows: The corporate and special purpose property taxes extended or abated for 2018 were \$1,184,454.38. The proposed corporate and special service property taxes to be levied for 2019 are \$1,471,733.56. This represents a 24.3% increase over the previous year.

The property taxes extended for debt service and public building commission leases for 2018 were \$0. The estimated property taxes to be levied for debt service and public building commission leases for 2019 are \$0. This represents a 0.00% increase over the previous year.

The total property taxes extended or abated for 2018 were \$1,184,454.38. The estimated total property taxes to be levied for 2019 are \$1,471,733.56. This represents a 24.3% increase over the previous year.

Chair Marlin opened the public hearing to the public. No one came forward.

There being no further business to come before the Cunningham Town Board, Chair Marlin declared the Public Hearing adjourned at 7:03 p.m.
