G. REPORTS OF SPECIAL COMMITTEES

There were none.

H. REPORTS OF OFFICERS

Mike Monson (Chief of Staff) responded to previous questions and concerns raised regarding aggregation:

- 1. Quarterly aggregation reports on the City's website and distributed to the Sustainability Advisory Commission were labeled by Homefield Energy and not the City.
- 2. Additional reports on the underlining power mix are forthcoming. Homefield Energy provided quarterly reports to the ICC about power mix. In a conversation with Mark Fanning of Homefield Energy he indicated their reports are generated by their own plants and they also purchase on the open market.
- Mark Pruitt is no longer a consultant with the City of Urbana.
 That relationship ended when the City hired Good Energy as its consultant.
- 4. Chicago just recently went with aggregation and got a price of 5.42 cents per kilowatt hour. Urbana's price beats that. Chicago's contract specifies no coal power; something Urbana would need more analysis on to determine what that means.

I. NEW BUSINESS

1. Mayoral Reappointment:

a. Building Safety Code Board of Appeals - Carl Webber

Mayor Prussing presented her recommendation for reappointment to the Building Safety Code Board of Appeals. Alderwoman Stevenson made a motion to approve the Mayor's recommendation. Alderman Lewis seconded. The motion carried.

The reappointment of Carl Webber to the Building Safety Code Board of Appeals was approved by Council by voice vote.

2. Motion to Rescind Ordinance No. 2012-12-109, "An Ordinance Providing for the Issuance of \$7,800,000 General Obligation Bonds, Series 2012, of the City of Urbana, Champaign County, Illinois, and Providing for the Levy and Collection of a Direct Annual Tax for the Payment of the Principal and Interest of Such Bonds"

Mayor Prussing explained that the motion made at last week's Council meeting approving Ordinance No. 2012-12-109 was made according to the title of the ordinance as it appeared on the agenda. However, the title on the ordinance itself differed from what was on the agenda and entered into record. Therefore, a motion is necessary to rescind this ordinance.
