2007 was very busy and productive year for the Building Safety Division. The following report describes the division's activity for the previous year. This information is presented in terms of number of permits, number of inspections and revenues generated by permit type. Revenue from the newly established rental registration program is reported. Also, included is time series information dating back to 2003. A report from the Housing Division is also included.

Total Building Safety revenue from all sources in 2007 was \$838,594. This amount is the highest ever generated by Building Safety and includes revenue from rental registration for the first time. The rental registration amount was \$275,861, which was collected during two separate billings. The initial billing during March 2007 was \$112,588 and the billing in November 2007 for this current year was \$163,388. The non-rental registration amount of \$534,388 was the third highest in the last five years and an increase over the \$485,283 collected in 2006. During the last five years Building Safety has collected a total of \$2,870,982, with an average of \$574,196 per year.

The total number of permits issued by the division in 2007 was 2,069. The average number of permits issued for the last five years was 2,260 and building activity has remained fairly steady over the last five years. Although revenue has fluctuated more due to the influence of large projects with high construction costs during certain years, a high level of building activity in the city has remained constant during the past five years.

The total number of inspections performed by the division in 2007 was 3,957. The average number of inspections for the last five years was 4,561. Inspection activity remains very busy, providing service to permit holders, contractors, and home owners.

In 2007, the Building Safety Division oversaw several larger on-going construction projects in Urbana, including Gregory Place Phase 2, The Pointe at the University of Illinois (at the former K-Mart site), the Pines at Stone Creek Commons shopping center including Busey Bank and Monicals Pizza, the Meijer's development, Carle's new clinic on Windsor, Christie's new clinic on Windsor, and Gateway Shop at Five Points West.

In 2008, the Division looks forward to another busy year for construction. Meijers, Carle, Christie, and Gregory Place II will be completed this year. Activity will start on the Stratum on University (160 Apartments), the U of I Gateway building at Lincoln and University, Family Dollar on Philo, new apartments in Town and Country and Eastland Suite Apartments. We also anticipate numerous other projects starting, including Milo's relocation, Common Ground relocation to Lincoln Square, and site work for Menards. Activity will be very high for Building Safety Staff in 2008.

After staff revision and public hearings the City Council and Mayor approved the adoption of the new model codes effective March 15, 2007. Education and acceptance have done well in the building community. The city has purchased the rights for the Property Maintenance Code to be displayed on the city web site. Building Safety Staff has incorporated the adopting ordinance and the code so that it is now available on line.

Building Safety Division along with the Finance Department instituted the new rental housing registration program on January 16, 2007. The initial billing was for 2/15/07-10/14/07 (8 months). Total collected was \$112,588. The billing period 10/15/07-10/14/08 collected \$163,272 through February. Building Safety handled numerous telephone and personal contacts during this time to educate and coordinate compliance. Housing inspectors completed field inspections to verify if dwellings were rental and forwarded delinquents to Finance for referral to our Legal Department. An 18-month review and report on the rental registration program is to be conducted starting in July, 2008.

Housing inspection activity for 2007 is also included in this report. In January 2007, a new Housing Inspector was hired which brings the total Housing Inspector staff to two.

Systematic inspections of multi-family residences were on-going and systematic inspection of single-family and duplex rentals was initiated in August. During 2007, a total of 1,289 multi-family dwellings contained in 125 buildings were inspected. That is an increase over 2006 from 704 dwelling units in 68 buildings. 74 single-family and duplexes were inspected beginning in August.

Our office received 50 tenant complaints this year, four more that last year. Several were vacated until repairs were made; the other complaints were resolved in a timely fashion.

The five year cycle of inspections of Carle properties was completed in accordance with the Carle/City agreement. Carle currently has 44 properties containing 48 dwelling

units. Other important programs were also completed by the Housing inspector staff, such as certified housing, mobile home parks, fire department follow-ups and Grants Management program inspections.

Building Safety Division support staff has worked very hard to keep up with permit activities and the additional work associated with the rental registration program. Our 1/2 time clerk has been increased to 3/4 time to give the Building Safety Division valuable help for our additional workload.






TOTAL NUMBER OF BUILDING PERMITS




TOTAL NUMBER OF PLAN REVIEWS




TOTAL NUMBER OF PLUMBING PERMITS




TOTAL NUMBER OF MECHANICAL PERMITS




TOTAL NUMBER OF ELECTRICAL PERMITS




TOTAL NUMBER OF UTILITY PERMITS




TOTAL NUMBER OF DEMOLITION PERMITS




TOTAL NUMBER OF SIGN PERMITS






TOTAL PERMIT REVENUE






TOTAL REVENUE FOR BUILDING PERMITS




TOTAL REVENUE FOR PLAN REVIEWS




TOTAL REVENUE FOR PLUMBING PERMITS




TOTAL REVENUE FOR MECHANICAL PERMITS




TOTAL REVENUE FOR ELECTRICAL PERMITS




TOTAL REVENUE FOR UTILITY PERMITS




TOTAL REVENUE FOR DEMOLITION PERMITS




TOTAL REVENUE FOR SIGN PERMITS




TOTAL REVENUE FOR CERTIFIED HOUSING CONTRACTS

SUBJECT: Housing Summary 2007

The Rental Registration Ordinance was adopted by City Council on January 16, 2007. Staff worked throughout the year with landlords, answering questions and concerns to ensure a smooth transition of the Ordinance. Staff met with the Central Illinois Apartment Association at numerous meetings to discuss the program and answer any questions the association may have encountered.

On February 12, 2007 City Council adopted the 2003 International Property Maintenance Code which constitutes minimum requirements and standards for all existing structures in the City.

In January 2007 a new Housing Inspector was hired which brings the total Housing Inspector staff at two.

1289 multi-family dwellings were inspected this year which were contained in 125 buildings.

Single family and duplex rental inspections began in August. Seventy four dwellings were inspected. Five major issues were discovered including not approved bedrooms, over occupied dwellings, and bedrooms lacking adequate ceiling height. The major issues were resolved or are currently being resolved with cooperative efforts between the landlords and City staff.

Upon inspection three single family rentals were discovered to have 0 violations and were issued an A class certificate. All other properties were assigned a B classification.

Our office received 50 tenant complaints this year, four more than last year, several were vacated until repairs were made, the other complaints were resolved in a timely fashion.

Eight buildings common areas were re-inspected by Building Safety Staff as a result of landlord's failure to comply with code violations that were discovered as a result of Urbana Fire Department systematic inspections. These violations were abated after Building safety sent an initial letter.

Fourteen properties were inspected for the Shelter Plus care Program which is currently administered by the County.

Seven problematic properties were referred to the City Legal Division. 1302 Berkely for unsanitary conditions is still pending possible demolition. 802 W. lowa for over-occupancy/zoning violations and is still pending in Circuit Court. 605 W. Green for occupying a SFR without a Certificate of Occupancy. 2310 E. Main a dilapidated SFR was demolished. Gabes Place at Washington Square was condemned and closed by the City. The property was brought up to code and later re-opened. Three pending Court cases were filed against Robert Martinez, owner of Scottswood and Woodstone properties.

Inspection of the Carle properties was completed in accordance with the Carle/ City agreement. Carle currently has 44 properties containing 48 dwelling units.

Inspection for the Certified Housing Program was started in September with final inspections completed in December. Twenty five properties were inspected which included a total of 1345 student residents.

SUBJECT: 2007 Certified Housing Inspection Results

During this inspection cycle, there were 25 properties inspected, the same number from last year. There were 89 significant violations discovered compared to 90 violations from the previous cycle.

The definition of a significant violation such as an exit light not illuminated on the checklist may have four or five locations on a property but only count as one significant violation.

To date, 14 of the 25 properties are sprinklered.

The number of properties that did not have any violations decreased from eleven to eight properties. They were:

There were 1,345 residents this year, a decrease of 21 resident from last year. Approximately 48 percent of the houses were cited for individual rooms exceeding the University of Illinois' housekeeping standards!






