Climate Action Plan Phase 2 Progress


Goal 3 Action 4: Propose strategies to improve the local onsite renewable energy market

The Midwest Renewable Energy Association has received five responses to their request for proposal for a solar installer for the third round of Solar Urbana-Champaign. The community advisory group is currently evaluating the proposals. We hope to have our first Solar Power Hours in April.

Additional Energy and Climate Activities

<u>Professional Exchange:</u> Staff met with the colleagues working on sustainability activities with the University of Costa Rica as well as the Center for Urban Sustainability located in San Jose, Costa Rica as part of a University of Illinois College of Education study abroad class exploring environmental education in Costa Rica.

<u>Public Engagement:</u> Staff spoke at a solar energy forum and a University of Illinois Department of Urban Planning class about the City's energy and climate activities.

U-Cycle

U-Cycle staff and Park District staff will be conducting a workshop on implementation and best practices for backyard food scrap composting.

On May 27, U-Cycle staff participated in the Illinois Product Stewardship Council (ILPSC) medical sharps stakeholder dialogue webinar. The ILPSC is working with the national Product Stewardship Institute (PSI) to develop a comprehensive program for end-of-life sharps management for consumers, whether via a drop-box scenario at a pharmacy, etc. or a mail-back program. Industry leaders and other stakeholders convened to discuss successes and challenges that other states with sharps initiatives, such as California, have faced. Healthcare industry leaders highlighted the pros and cons of having sharps collections available and some of the regulatory hurdles. The sharps initiative is one that the ILPSC hopes will be implemented. There are safety concerns with sharps in both the waste stream and at recycling MRFs, along with public exposure at parks and public areas. This initiative will be the focus of the ILPSC in 2018.
