a. Empowering the Community to Combat Community Violence by First Followers – CMs Wilken and Bishop

Presented by Dr. Regina Parnell of First Followers. Thanked council and mayor for allowing time for the presentation this evening. Acknowledged the work of the late Mrs. Mitchel. Shared a PowerPoint presentation on First Followers plan to address community violence and explaining trauma. Questions and discussion ensued.

b. Current State of Local Support for Survivors by CU Trauma and Resiliency Initiative (CU TRI) – CMs Wilken and Bishop

Presented by Karen Sims of CU TRI. Presented a PowerPoint presentation on resources available to support survivors and community members impacted by community violence. Explained the structure and services of CU TRI. Questions and discussion ensued.

Mayor Marlin read the public input guidelines. *Allan Max Axelrod* provided an update on the utility shutoff moratorium campaign and urged Council to pass a resolution of support. *Corey Mallory* wanted to expand further upon First Followers presentation from earlier. *James Tygar Corbin* wanted to add more to the First Followers presentation and explained the impacts of trauma on individuals and how the program helps individuals address traumas. *Sarah Nixon* thanked council for this evenings organizational presentations. Spoke in support of CU TRI's work within the community. Stressed the importance of utilizing resources to address community violence. *Marlem Mitchel* thanked council for space given to First Followers to talk about their programs. Wanted to provide additional information about First Followers organization.
