PUBLIC INPUT

Public input will be taken in the following ways:

Zoom Webinar participant

Click on the link above to join the Webinar. You must provide your name and email in order to join the Webinar. Participants will be muted except when they are called on to speak; video will remain off for all members of the public when speaking. You may speak for up to five minutes.

Telephone participant
