Dear Resident,

Thank you for your interest in the City of Urbana's Emerald Ash Borer Assessment and Treatment (EABAT) Program. The Urbana EABAT program is a one-time treatment program for residents who have healthy ash trees on their property or adjacent city parkway. The treatment will be in the form of an Emamectin Benzoate injectable and lasts two to three years before the tree needs another treatment. The program is a one-time treatment program and ongoing treatments will be at the discretion and cost of the resident. The purpose of the EABAT program is to assist Urbana residents with maintaining healthy ash trees, awareness of EAB and acknowledgement of the need for treatment or removal of the tree.

Treatment of ash trees will require a tree health assessment by the City to ensure the tree has a better than average chance of surviving EAB with treatment. Once the tree is deemed sufficiently healthy the resident, if interested, will be asked to provide payment, \$7.50 per diameter inch per tree prior to treatment. Payments are to be made out to "City of Urbana" and are non-refundable. Trees will be treated by the city from the last half of May through June or later depending on weather. **The EABAT program funds are limited and applications will be considered on a first come basis.**

If weather is dry at the time of treatment you may be asked to water the area around the tree the week before and after treatment.

MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF URBANA, ILLINIOS,  
AND  
CERTAIN QUALIFIED OWNERS OF PROPERTY FOR AN EMERALD ASH BORER  
ASSESSMENT AND TREATMENT PROGRAM

The City of Urbana, Illinois, a Municipal Corporation, by and through its Arbor Division, hereinafter referred to as the City, desires to enter into an emerald ash borer assessment and treatment program with the owner(s) identified, for the assessment and possible treatment of ash trees on private property and or property within the adjoining or adjacent street right-of-way of the City, and said qualified owner(s) of such private property and or property within the adjoining or adjacent to the right-of-way of the City agree to co-operate in and abide by the provisions contained herein. For the purposes of this program and in order to be eligible therefore, the property or properties of said owner(s) must have a sufficiently healthy ash tree as determined by the City Arborist.

1. The City will determine if an ash tree(s) is sufficiently healthy for treatment.
2. The City will select and treat all trees in connection with this program.
3. The City will purchase any and all tree injection products provided in connection with this program.
4. The Owner(s), in order to participate in this program, must first express a desire to do so and, if multiple owners of contiguous properties are involved, said owners should designate a person or persons to represent said owners for the purposes of coordination with the City Arbor Division.
5. The Owner(s) will pay to the City \$7.50 per diameter inch of tree/s treated in private property and or City right-of-way adjacent to or adjoining the property or properties of said Owner(s).
6. The Owner(s) further agree to water, as required, any and all treated trees in connection with the program through the first summer after treatment. **The owner further agrees to not plant any flowers under new tree or install any edging around the base of new tree, both of which would impair the treatment and are common causes of root damage. Success of the treatment is not guaranteed and there shall be no refund for trees that fail or die.**
