## a. Proposed Changes to HRC Ordinance

Peter Resnick gave an update on HRC ordinance proposed changes. Commissioners discussed issues such as jurisdiction, conflicts of interest and proposed changes. Mr. Resnick suggested changing the ordinance to allow outside council to handle complaints against the City in order to alleviate some of the conflicts of interest. He also suggested adding language that would reflect the City's commitment to living up to the spirit of the ordinance regardless of the outcome. Ms. Rigberg stated her desire to hear more from other commissioners before forming an opinion in order to allow all possible sides to be heard. Rev. Caplow liked the suggestions mentioned and the direction things were moving, but

agreed with Ms. Rigberg that other commissioner's opinions should be heard before forming a final opinion.

Chair Frances Rigberg introduced Lemond Peppers as the new Community Engagement Coordinator for the City of Urbana. Mr. Peppers shared his vision and goals for the future.
