

Urbana Arts and Culture Program
Final Report – The Afro-Caribbean Jazz Collective

I am very grateful for the opportunity the Urbana Arts and Culture Program gave to us. Initially the grant budget was meant for the Salsa Night with the Afro-Caribbean Jazz Collective, but plans changed after the pandemic hit in March. We had already agreed with Jenelle Orcherton to have the event coincide with the CU Jazz Festival and the Rose Bowl Tavern as the host of the event. When Jenelle reached out in August, I decided to change the initial proposal from a dance party to a compositional and musical exploration where I would write music using African descendant rhythms found in the Greater Antilles.

The grant was used to expand the original repertoire of the Afro-Caribbean Jazz Collective. By the end of September, I had completed eight new compositions and nine incomplete compositions which I plan on finishing for the remainder of the year. Between researching the grooves and rhythms of the Greater Antilles, composing the songs, and arranging the parts all eight musicians, these seventeen compositions took me approximately forty-five hours to complete in the span of a month and a half. We also had to rehearse the new compositions with the whole group, this took eight hours. This is not including individual practice time which can number up to three hours per day, minimum. Promoting tools were limited to Facebook events and posts as well as the CU Jazz Fest website. I also had the opportunity of being part of the Entrepreneurial in the Arts panel as well presenting some compositions at the Gies College of Business on Tuesday October 6, 2020 as part of the Hispanic Heritage Month. I also used this platform to promote the event while mentioning the grant.

The event took place on October 9, 2020 at the Rose Bowl Tavern. Charlie Harris oversaw the lighting and sound engineering of the event. He made the group feel extremely comfortable and the audience enjoyed the performance. The Rose Bowl had several big picnic tables, probably fifteen tables, on the outside for guests to sit and enjoy the concert. Although I heard that people wanted to dance, I had to discourage it several times on the microphone. I did not want the audience to break with state guidelines or even worse, get someone sick. The event was a success, exceeding the Rose Bowl's administrations expectations of an audience. Even the Courier Café had a tent in the outside and they also applauded and enjoyed the live music. This event was the second time that I performed in seven months, which is not the norm for a professional musician. For some band members, it was the first time in a live setting since February. Several audience members expressed their joy of hearing live music after months.

Sadly, the dance party had to be postponed, with good reason, but I am confident in saying this event fulfilled the mission of putting Latin music in the forefront at a high level of performance. Hopefully once everything returns to a level of normalcy, we will have a dance party like no other.

Thanks to Rachel Storm for her guidance through the process and I look forward to future collaborations with the Urbana Arts and Culture Program.
