I am pleased to submit the Fiscal Year 2021Staff Appointments for your approval.

I have also listed several positions that have been moved into civil service over the past year. These include the Sustainability and Resilience Officer in Public Works and two positions in Human Resources & Finance – the Administrative Services Manager and Financial Services Manager. In addition, the Planning Manager will be replaced by a Principal Planner position, which will also be in civil service.

Several vacant positions are also listed. Recruitment is underway for two Division Chiefs in the Fire Department, and I expect to recommend appointments to those positions no later than July. We continue to search for a Public Works Director, and are reviewing the status of the Economic Development Manager position. On a short-term basis, those activities will be managed by existing staff.

I am pleased to submit for your consideration the appointment of Phyllis D. Clark to fill the unexpired term of former Clerk Charles Smyth. Ms. Clark served as Urbana City Clerk for 24 years. She graduated from the first Leadership Enhancement and Development Session (LEADS) through Government Affairs at the University of Illinois. She is a Master Municipal Clerk, served as a mentor for newly elected/appointed Clerks in District 6 and presented sessions on Parliamentary Procedure and Duties of the Clerk as it relates to Home Rule and Non-Home Rule Communities.

She worked with the Illinois Municipal League as a Clerk representative on the Legislative Committee and served as District 6 Director of the Municipal Clerks of Illinois. She also served as President of the Central Illinois Municipal Clerks Organization and President of the Municipal Clerks of Illinois.

Ms. Clark was a Governor's appointee to serve on the Institute Training Committee, where she served as Secretary, Treasurer, and President of the ITC.
