- To apply for a mobile home park license with the City of Urbana, complete this form and return it to the Finance
 Department, 400 South Vine St., Urbana, Illinois, 61801.

 The Finance Department will route the application for approval and mail the validated license to you.
- 2. Attach a complete listing of the existing mobile homes, the owners and the owners' mailing addresses.
- 3. If this is your <u>first</u> application, the following information must be returned with the completed application and the license fee:

<u>PLAT:</u> A scaled map, plan, or layout showing the subdivision of land and indicating the location and, boundaries of the individual lots. The plat should also provide, but not be limited to, the following information:

- A. The name, location, or address of the mobile home park, the park owner and operator;
- B. The location of all property lines, existing streets, easements, utilities, sewers, and any other significant features;
- C. The date of the plat (map or layout), North arrow, graphic scale (not less than I" to I00'), on all drawings submitted;
- D. All buildings, structures, and mobile home stands;
- E. Total number of mobile homes sites;
- F. Approximate gross density per acre; and
- G. All mobile home parks located in a flood plain shall file evacuation plans indicating vehicular access and escape routes, including mobile home hauler routes, with the appropriate disaster preparedness authorities.
