

**ORDINANCE NO. T-2019-12-003**

**AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR THE TOWN OF  
CUNNINGHAM, CHAMPAIGN COUNTY, ILLINOIS, FOR THE TAX YEAR 2019,  
COLLECTIBLE IN 2020**

**BE IT ORDAINED** by the Township Board of the Town of Cunningham, Champaign County, Illinois, as follows:

**SECTION 1:** That, pursuant to the authority granted by the Township Code, Illinois Compiled Statutes, Chapter 60, Article 235, and such other statutes as are applicable, the sum one million, three hundred eighty seven thousand six hundred thirty one and no cents (\$1,471,734) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund,	\$ 761,000.00
General Assistance Fund	\$ 626,631.00

for the tax year 2019, collectible in 2020.

**SECTION 2:** That the amount levied for each object and purpose shall be as follows:
