



Overview of Economic Development Incentive Programs

Urbana’s Economic Development Incentive Programs encourage the redevelopment of vacant and underutilized buildings, catalyze capital investment in the City’s Tax Increment Financing districts, and foster a vibrant, inclusive, and creative business community in Urbana. Use the chart below to identify the incentives which are most suitable to your project. All programs are subject to fund availability.

Overview of Incentive Programs: Eligible Use Definitions

Priority Eligible Uses

To qualify for a particular Use, at least 70% of floor space must be dedicated to that Use.

Retail Stores, Restaurants & Bars

- Establishments that fall under the definition of “Retail Store” ,“Food Service Establishment” or “Tavern” in the Urbana Zoning Ordinance.

Hotels and Conference Centers

- Establishments that fall under the definition of a “Hotel or Motel” in the Urbana Zoning Ordinance.

Upper-Story Residential Units

- Projects that result in the creation of new, upper-story “Dwelling Units” as part of a mixed use development.

Creative Industry Establishments

- Establishments that primarily focus on “Creative Industry” as defined in the attached chart; **and**,
- At least 70% of premise floor area is dedicated to:
 - a performance venue, exhibition space, or demonstration area for creative products or services,
 - a studio, rehearsal space, workshop, classroom, or other maker space,
 - an archive, museum, or library,
 - an office, meeting space, or collaborative work area specifically for “Creative Industry” employees,
 - a use that is directly related to the production of a creative product or service, **or**
 - any combination of the above uses.

Destination and Entertainment Business

- Establishments as defined as an “Assembly Use” by the 2009 International Building Code.

Disadvantage Business Enterprise (DBE)

- Establishments that fit the definition and requirements of a minority or female owned business as set forth in the Business Enterprise for Minorities, Females and Persons with Disabilities Act [30 ILCS 575/2](#).

Any Combination of Priority Uses

- Establishments where at least 70% of premise floor area is dedicated to any combination of Priority Uses.

Philo Road Business District

- Any Eligible Use located in the Philo Rd Business District will be considered a Priority Use

Other Eligible Uses

Professional Services

- Including financial, legal, medical, and other office uses.

Personal Services

- Including beauty, health, fitness and automotive repair.

Any use that is not specifically defined as a Priority Use or an Ineligible Use

Ineligible Uses

Any use on a tax-exempt property is ineligible for TIF-funded assistance

Any use that does not meet all applicable City codes is ineligible for funding

Religious institutions, private clubs, advocacy or lobbying groups, or political campaigns are ineligible for funding

Required for All Business Establishments

- Certificate of Occupancy

Required for Most Business Establishments

- Fire Prevention Permit

Required to Construct or Alter a Building

- Building Permits and/or Demolition Permits

Required to Install or Alter a Sign

- Sign Permits and/or Temporary Sign Permits

Required for All Home Businesses

- Home Occupation Permit



City of Urbana Central TIF & TIF Two Districts


