**A RESOLUTION SETTING COMPENSATION OF CUNNINGHAM TOWNSHIP OFFICIALS FOR THE
FOUR YEAR TERM BEGINNING MAY 17, 2021 (CUNNINGHAM TOWNSHIP SUPERVISOR,
CUNNINGHAM TOWNSHIP CLERK AND CUNNINGHAM TOWNSHIP BOARD), AND BEGINNING
JANUARY 01, 2022 (CUNNINGHAM TOWNSHIP ASSESSOR)**

WHEREAS, according to 60 ILCS 1/65-20, the compensation of township officers shall be set by the township board at least 180 days before the beginning of the terms of office; and

WHEREAS, according to 35 ILCS 200/2-70, the compensation of the township assessor shall be set by the township board at the same time the board sets the compensation of its township supervisor;

NOW, THEREFORE, BE IT RESOLVED by the Township Board of the Town of Cunningham that the compensation of the township officials by the Township for the four year term beginning May 17, 2021 and ending May 18, 2025 for the township supervisor, township clerk and township board, and beginning January 01 , 2022 and ending December 31 , 2026 for the township assessor, shall be as follows:

SECTION 2:

In addition to the compensation stated above, the Supervisor and Assessor of the Township shall be provided health insurance and IMRF on the same terms and conditions provided heretofore, namely such insurance as is provided to employees of the Township Supervisor and Assessor, under the Cunningham Township insurance program, with the premium for individual coverage paid for 100% by the Township and if selected, family coverage is provided at reasonable cost to be equal to what employees of the Township pays.
