

**Schedule E of the Urbana Local Traffic Code  
Ssection 23-73 (d)**

d) Whenever authorized signs are erected indicating that vehicular traffic facing a steady red signal is prohibited from turning right after stopping, as required by law, no driver of a vehicle shall disobey the directions of any such sign. The placing of such signs in the places indicated by Schedule E is herewith approved.
