a. Consideration of Taser Report U19-579

Tony Allegretti shared that Ordinance 19-43 shares the CPRB may not vote Up or Down or enforce discipline or any action against an officer in regards to Taser usage. The CPRB can make recommendations about what the Taser Policy should be, or policy changes.

A full Taser review is set over for the next scheduled meeting on December 22, 2021. The CPRB decided to review Taser Usage cases quarterly moving forward in 2022.
