Carol Mitten shared the legal guidance the City received that will not allow the CPRB to accept complaints based on video. Doing so would violate the collective bargaining agreement. Ms. Mitten answered questions from Board members.

Scott Dossett stated that there are currently 64 appeals and 92 complaint submitted so far in 2020. Efforts are being made to schedule an appeals hearing soon.
