Town Bills

- Town fund = \$575,805.20
- General Assistance Fund = \$114,005.39
- TOTAL: \$689,810.59 in expenditures

General Assistance

Monthly support for Urbana residents who are disabled or out of work.

- 99 Current Participants
 - o 47 on the Employment and Education Opportunities Track
 - 42 on the Disability and Wellness Track
 - 10 on the SOAR Track to receive support for SSI Apps
- 40 are homeless
- 62 males / 37 females / 0 transgender or gender non-conforming
- 43 is the average age
- The Community Work Program is being retooled as the Employment and Education
 Opportunities track and opened starting August, 2021 with expanded work and training
 opportunities.

Rental Assistance

Rental assistance for Urbana households behind on rent or homeless moving into housing.

- 15 households were supported with Rental Assistance last month.
- We are providing up to 3 months of rental assistance while funds last. Currently, we have enough options that any applicant who lives in Urbana making 200% of the poverty level or below is able to be helped.
- Rental arrears larger than \$2500 are being referred to RPC or the <u>State of Illinois IDHS</u> <u>program</u>, which will take applications again starting June 28th and will pay up to 15 months or \$25,000 in assistance for COVID-impacted households up to 80% of Area Median Income.

Utility Support

Utility bill support for Champaign County residents who do not qualify for other support programs.

- This fund was created by the Unitarian Church and 4 faith based groups have donated to date.
- LIHEAP closed earlier in June and we have experienced an increase in utility assistance calls. We have used \$7,556.37 in expenses to pay off 7 power bills and 9 water bills.
- There is a \$18,231.04 balance in this fund. We will be requesting additional donations to carry us through the season as we expect to expend all funds prior to LIHEAP reopening in the Fall.

Housing Advocacy

Housing advocacy for participants who are homeless or at risk of homelessness to access all available subsidized housing opportunities, and help for homeless residents to furnish their new homes.

- 128 General Assistance participants representing 87 households received help applying to subsidized housing since our advocacy program began July 1, 2020. This year 23 households have successfully moved in!
- 13 residents with disabilities helped so far apply for the open waitlist for Pinewood Place in Urbana.
- 5 homeless households have been assisted with the Township Housewarming, since the program began in February, 2021. They received vouchers to buy furniture and housewares at Salt and Light and Habitat for Humanity Restore.

Emergency Housing

Emergency Housing for families with children in Urbana schools of Crisis Nursery or residents with disabilities who are referred from CU at Home.

- With the reduction of services at CU at Home, we are currently over capacity with 9
 households and have moved case management staff time over to support this.
 - We are housing 5 male GA participants who used to stay at CU at Home. Our other street homeless GA participants are staying at CU at Home to remain on track for housing subsidies.
 - We recently had several families exit, so we have 1 family, 2 disabled females in shelter, and 2 active family referrals.
- Average hotel stay is 37 days.

Bridge to Home

A rapid rehousing program providing housing stabilization and up to 12 months of rent for literally homeless individuals and families in Champaign County, referred by Centralized Intake for the Homeless.

- We are currently working with 3 single men.
- We have 2 new referrals for 2 families.

Budget FY 22

The Draft budget was put on file by the town board on May 10, 2021. Since then, we have made a few changes to the budget based on emerging information. The final budget is provided to the town board and public. Significant changes between draft and final for Supervisor and General Assistance divisions include:

INCOME

- The addition of an anticipated \$700,000 in COVID relief funds to offset increases in personnel and program expenses during the pandemic. We anticipate a \$500,000 deficit in the current FY21 budget.
- We confirmed \$284,696 in DHS Rapid Rehousing Funds through 3 subgrantee agreements with the City of Urbana.
- Our initial projections for interest income, which has grown from 3k to 46K per year thanks to strategic investing, was off. We have reduced this line item from 10K to 4K.

EXPENSES

- Unfortunately, MTD has announced it will go back to requiring bus fares this Fall, so we added \$20,000 in anticipated expenses so that GA participants can travel to work, school and health care.
- \$20,000 is added to our redesigned Employment and Education Opportunities Program (formerly Community Work Program) to support GED completion, training and certification.
- We received firmer estimates on Property costs at the California Avenue properties and have updated expenses with these.

Changes in the Assessor's budget between draft and final are detailed here:

"Since I last submitted the Assessor's proposed FY 22 budget, and after consulting with the Township Supervisor and staff, I am now submitting a new proposed FY 22 budget. The changes are as follows: I request an additional \$600 for utilities for the Lincoln Square office space. The

current lease allows for the first \$50 of utility costs per month to be paid by the landlord, and the remainder paid by the township. I thought it was prudent to request what equates to \$50 per month in potential utilities expenses. I have zeroed out the computer line item and combined it with computer software. I am also requesting an additional \$2,100 for access to Citizenserve- the online system the City of Urbana uses for building permits. I have also reduced the training budget by \$500 and moved that to the travel line item to cover gas expenses for the Township car. I have increased the Miscellaneous expenses by \$400, as I will use this line if I am to purchase any perpetual licensed software. I have also increased the legal line item by \$20,000 as the Township Supervisor and I felt it would be best to track legal expenses by division for better transparency. In summation, I am requesting an increase of \$22,700 to my proposed FY 22 budget. If you take out the legal expenses, this represents an increase of \$2,700; \$600 for utilities and \$2,100 for permitting software service.
