CLASS OF TEMPORARY LICENSE APPLIED FOR

Class T-1	Shall permit and allow a current license holder to sell alcoholic drinks for consumption in an enclosed area, without regard to where payment is made, immediately adjacent and adjoining and opening onto the premise described in the then current license application on file.
Class T-2	Shall permit the retail sale of alcoholic liquor by any bona fide civic, service, charitable or other not-for-profit organization for consumption on the premises or within an area specifically designated in such license.
Class T-3	Shall permit the retail sale of alcoholic liquor by a bona fide private for-profit promoter or outdoor festivals, held with the City's corporate limits, for consumption on the premises or within an area specifically designated in such license.
Class T-4 – Festival Sponsor	For persons who seek or intend to host festival events at which other persons will be conducting tasting and/or offering package alcoholic liquor for sale in conjunction with such tasting.
Class T-4 – Tasting	For persons who seek or intend to directly offer tasting and sell package alcoholic liquor in conjunction with such tasting.

- 2. The application fee and per diem fees (if applicable) in such amounts as set forth in Chapter 14, Section 14-7 of the City Code.
- 3. Map of area where event is to be held.
- 4. Letter from owner of premise giving consent.
- 5. A copy of 501 C (3) from Secretary of State (for not-for-profits).
- 6. A Security Plan as set for in Sec. 3 -42 of the Urbana Liquor Code.
- 7. Copy of State of Illinois issued liquor license , if applying for a T-4 license.

LIQUOR LICENSE AFFIDAVIT

I, _____, as an authorized representative of _____
attest that:

- a. the applicant shall not permit a consumer to take any cup, glass, or other container containing alcoholic beverages beyond the boundary for the Event premises;
- b. no person under the age of twenty-one (21) year shall be permitted to offer alcoholic liquor for sale;
- c. no person under the age of twenty-one (21) shall be served any alcoholic beverages;
- d. the applicant would not be disqualified from receiving a liquor license, if sought, by reason of any matter or thing stated in the Urbana City Code or the laws of the State of Illinois;
- e. the applicant has not been convicted of any felony in any state or federal jurisdiction which would otherwise deny the applicant liquor license;
- f. the applicant shall abide by the Urbana City Code and the laws of the State of Illinois in conducting the Event;
- g. affirms that all statements made in the application for the temporary license are true and correct;
- h. understands that by submitting the application and the information requested herein and thereby, along with the fees required, the City in its exercise of reasonable discretion may deny the application for the Event and if such application is denied the City will refund any fee or fees tendered.
- i. has read and understands, Section 3-42, Class T Licenses of the Urbana City Code.
